# 4.0 Regular Agenda

4.1 Accept and Forward to the Consolidated Emergency Dispatch Agency Commission the Year-End Budget Accounting for Fiscal Year 2019/2020

SR911 Administrative Service Manager John Bettencourt (Bettencourt) shared the Fiscal Year 2019/2020 surplus from operating expenses was calculated at \$272,325. Staff had projected the surplus at \$325,000, which is committed to approved Fiscal Year 2020/2021 charges. On November 20, 2019, the Consolidated Emergency Dispatch Agency Commission approved the use of \$90,000 of Fiscal Year 18/19 Budget Surplus funds to finance the G2 Automated Dispatch System. After a collaborated effort with County OES-Fire Warden and Modesto Fire Department, it was determined that SR911's contribution to this project could be met with OES grant funding, resulting in a savings to the Agency of \$90,000. The net surplus for Fiscal Year 2019/2020 is \$37,325. Staff recommends using the \$37,325 of net surplus to reimburse the Agency Contingency Fund. The Fiscal Year 20/21 Budget was supported using \$115,605 in Contingency Funds. This is 25.6% of the Department Contingency Fund total. The Contingency Fund would increase from \$335,395 to \$372,720. Bettencourt went over the Fiscal Year 2019-2020 Budget Surplus Calculation.

Motion to Accept and Forward to the Consolidated Emergency Dispatch Agency Commission the Year-End Budget Accounting for Fiscal Year 2019/2020 approved by Ferriera, seconded by Walker, unam. 4-0

4.2 Agreement to Recommend and Forward to the Consolidated Emergency Dispatch Agency Commission the Stanislaus Regional 9-1-1 5-year Capital Improvement Plan

Silva shared the Capital Improvement Plan is updated each year to assist with the future planning of agency project costs. This plan is presented for consideration of the Dispatch Advisory Board prior to the presentation for adoption at the Consolidated Emergency Dispatch Agency Commission meeting scheduled for September 16, 2020. Silva went over the 5-Year Capital Improvement Plan and items requested for Fiscal Year 2021-2022.

Motion to Recommend and Forward to the Consolidated Emergency Dispatch Agency Commission the Stanislaus Regional 9-1-1 5-year Capital Improvement Plan approved by Ernst, seconded by Ferriera, unam. 4-0
